

## REPORT AND WIN A CAN-AM OFF-ROAD OUTLANDER PRO HUNTING EDITION OFFICIAL SWEEPSTAKES RULES

WINNER DRAW: January 31, 2025

AGREEMENT TO AND ACCEPTANCE OF THESE OFFICIAL RULES. By entering REPORT AND WIN A CAN-AM OFF-ROAD OUTLANDER PRO HUNTING EDITION (the "Sweepstakes"), Participants (as defined below) automatically agree to accept and abide by these official rules (the "Rules"). All decisions of the Sponsor (as defined below) with respect to any aspect of this Sweepstakes, including without limitation the eligibility of entries, are final and binding on all Participants in all matters as they relate to this Sweepstakes.

## VOID WHERE PROHIBITED BY LAW

- 2) SWEEPSTAKES PERIOD. The Sweepstakes Period to enter into this Sweepstakes is for a limited time. Participant may enter the Sweepstakes as of July 29, 2024 at 9:00 am ET until January 19, 2025, 11:59 pm ET (the "Sweepstakes Period"). No entry received before or after the end of the Sweepstakes Period will be accepted.
- **SPONSOR.** The Sweepstakes is sponsored by Bombardier Recreational Product Inc. ("BRP" or the "Sponsor"), 726, rue St-Joseph, Valcourt, Quebec, J0E 2L0.
- 4) NO PURCHASE OF ANY BRP PRODUCTS NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY BRP PRODUCTS WILL NOT INCREASE YOUR CHANCES OF WINNING.
- 5) ELIGIBILITY. This Sweepstakes is open to legal residents of the province of Ontario, Canada who (i) have reached the age of majority in the province of Ontario as of the date the Sweepstakes Period begins, (ii) have a valid driver's licence, (iii) provide a valid email address (iv) provide valid contact information. (v) who have a valid Outdoors Card issued by the Ministry of Natural Resources of Ontario (the "MNR") and who provide the last nine (9) digits of their Outdoors Card, (vi) who bought a hunting licence and / or tag issued by the MNR and (vii) had and properly fulfilled their obligation to complete a hunter report in respect of a hunt that occurred in 2024 (i.e. for in respect of hunts occurring in spring or fall/winter of the 2024 calendar year) pursuant to Part X.1 of Ontario Regulation 665/98 (Hunting) made under the Fish and Wildlife Conservation Act, 1997, S.O. 1997, c, 41, (viii) at the time (and if) selected as the Winner (defined below), has not had their license (or their ability to get a license from the MNR) suspended for any reason; and (ix) is not an employee of the Ontario Public Service or member of the Executive Council of Ontario, or the spouse, parent, child, sibling or any individuals living in the same household (whether related or not) of any of the foregoing. Note that hunters that complete a hunter report in spring 2024, before the contest begins, are eligible to participate if they fulfill all other eligibility requirements. Note that it is not mandatory to have hunted, killed or harvested an animal to participate. Note that hunters that are not legal residents of the province of Ontario (ex: a hunter from another Canadian province or from another country) are not eligible to participate in the Sweepstakes and will be excluded.

All entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of the Rules may be disqualified by the Sponsor, to his sole discretion, acting reasonably.

Participants may submit only one (1) eligible entry per hunter report completed and submitted to the MNR during the Sweepstakes Period. Each unique eligible submission will count as one (1) entry into the Sweepstakes. No matter the number of entries, a Participant may only win one (1) prize related to this Sweepstakes.
